KBER 101's "\$25 GIFT CERTIFICATE TO CANCUN CAFÉ DOWNTOWN " CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. (i) <u>On-Air</u>: Listen to the Station weekdays from 6:00 am MT to 10:00 am MT during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 801-570-KBER (5297). Caller thirteen (13) to the Station, as determined by the Station in its sole discretion, will be eligible to win a Prize (as defined below). <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** Each weekday during the Contest Period, Station will give one (1) cue to call during the time frame listed above. Caller thirteen (13) as announced by the Station will win a Prize Winners will be notified during the call and may be awarded a prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to claim a prize within thirty (30) days of notification will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
