KBER 101 "WIN A DIGITAL DOWNLOAD TO SPELL" CONTEST OFFICIAL RULES

The Station will conduct the **KBER 101** "WIN A DIGITAL DOWNLOAD OF THE SPELL" CONTEST (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 2. Contest Period. The Contest will begin at approximately 6:00am MT on November 23rd, 2020 and will run through 10:00AM MT on Wednesday November 25th, 2020 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
 - (i) <u>On-Air</u>: Listen to the Station weekdays during the Contest Period. When the Station gives a cue to call, listeners should call the Station at 801-570-KBER (5297). Caller thirteen (13) to the Station, as determined by the Station in its sole discretion, will win a Prize (as defined below) play the on air game for the opportunity to win a Grand Prize (as defined below). <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Winner Selection.** On or around 10:00AM MT each day of the Contest Period, Station will give one (1) cue to call. Caller thirteen (13) as announced by Station will win a Prize. Grand Prize Winners will be notified during the call and may be awarded a prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to claim a prize within thirty (30) days of notification will result in disqualification and forfeiture of the prize.

The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.
