KBER 101 "Win a Digital Streaming Code to See the Mauritanian" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, ages eighteen (18) or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 90 Days. and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 90 Days.  - (i) <u>On-Air</u>: Listen to the Station weekdays during the Contest Period. When the Station gives a cue to call, listeners should call the Station at 801-570-KBER (5297). Caller thirteen (13) to the Station, as determined by the Station in its sole discretion, will win a Prize (as defined below) play the on air game for the opportunity to win a Grand Prize (as defined below). <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Winner Selection.** On or around 10:00AM MT each day of the Contest Period, Station will give one (1) cue to call. Caller thirteen (13) as announced by Station will win a Prize. Grand Prize Winners will be notified during the call and may be awarded a prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest.
