## KBER 101 "Win 2 Tix to A Day To Remember at the Saltair on October 14th " Contest Official Rules

A complete copy of these rules can be obtained by contacting radio station KBER 101 ("Station"), 434 Bearcat Drive Salt Lake City Utah, during available business hours Monday through Friday, on the Station website www.KBER.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the KBER 101 "Win 2 Tix to A Day To Remember at the Saltair on October 14th" CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
- 2. Eligibility. - Contest Period. The Contest will begin at approximately 6:00am MT on Thursday October 7th, 2021 and will run through 10:00AM MT on Thursday October 7th 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

- 5. On-Air: Listen to the Station weekdays during the Contest Period. When the Station gives a cue to call, listeners should call the Station at 801-570-KBER (5297). Caller thirteen (13) to the Station, as determined by the Station in its sole discretion, will win a Prize (as defined below) play the on air game for the opportunity to win a Grand Prize (as defined below). *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded.
- 6. **Winner Selection.** On or around 6:00AM through 10:00AM each day of the Contest Period, Station will give one (1) cue to call. Caller thirteen (13) as announced by Station will win a Prize. Grand Prize Winners will be notified during the call and may be awarded a prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation

of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to claim a prize within thirty (30) days of notification will result in disqualification and forfeiture of the prize

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a entrant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use, non-use or misuse of the prize.
