## KBER 101 "Win 2 Tix to Trans-Siberian Orchestra at Vivint Arena on Tuesday, November 23 at 7:30 pm" Contest Official Rules

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

- 5. On-Air: Listen to the Station weekdays during the Contest Period. When the Station gives a cue to call, listeners should call the Station at 801-570-KBER (5297). Caller thirteen (13) to the Station, as determined by the Station in its sole discretion, will win a Prize (as defined below) play the on air game for the opportunity to win a Grand Prize (as defined below). *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
