KBER "IN THIS MOMENT & ICE NINE KILLS ONLINE" CONTEST OFFICIAL RULES

The Station will conduct the **KBER** "In This Moment & ICE NINE KILLS ONLINE" CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Failure to respond to the initial verification contact within Twenty Four (24) hours of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
